To reach the goal of prediction of electrochemical behavior from first principles, it appears increasingly evident that an intermediate stage, between ab initio calculation and Monte Carlo or classical molecular dynamics, will be required. Here we report results of the self consistent tight binding methods we have developed for this purpose as they have been applied to the study of water on several oxide surfaces.
