## Submission Instructions

### ECS Biannual Meetings

#### About *ECS Transactions*

*ECS Transactions* is the official conference proceedings publication of The Electrochemical Society. Featuring full-text proceedings from ECS and ECS-sponsored meetings, ECST is a high-quality venue for authors and an excellent resource for researchers. All papers published in *ECS Transactions* are reviewed to ensure they meet generally accepted scientific standards.

#### Prepare your manuscript

Check the call for papers to determine if your symposium will be publishing its proceedings in an issue of ECST. If your symposium has planned an issue of ECST, you can begin preparing your full-text manuscript as soon as you've submitted your meeting abstract.

Use the [ECST Manuscript Template](#), and carefully follow the [ECST Author Instructions](#) while preparing your manuscript. Although there is no formally enforced page limit, the average ECST paper is about 12 pages long.

#### Submit your paper

The ECST submission system opens approximately four months before the corresponding ECS meeting. At that point, corresponding authors will receive an email with a link and login credentials for the system.

Upon entering the system, carefully review and update the preloaded information (title, abstract, author listing, etc.), as this is the information that will be used for publication.

Before submitting your manuscript, review the [ECS Transfer of Copyright Agreement](#). Indicate whether or not you consent to the agreement as it is written. If you do not accept the agreement as it is written, you may email a revised and signed form to [ecst@electrochem.org](mailto:ecst@electrochem.org).

#### Approve your proofs

After your paper has been uploaded, the system will convert your file to a PDF proof. To approve your proof, click the Upload Manuscript button again.

A window will pop up displaying any files that have been uploaded to the system. You will be required to view your converted file and verify that it is correct and free from errors (display, spelling, or other). It is extremely important that the proof looks exactly as you want your paper to appear, as this is what will be published.

If you are happy with the converted file, toggle the Submitter Approval field. If you do not complete these steps to approve the proof, your submission will be incomplete and your manuscript will not be visible to the reviewers.

#### Revise and resubmit

Once your paper has been reviewed, you will receive an email notification with a list of comments and requested revisions. Please be sure to address all comments in your revised manuscript in order to ensure that the paper is not sent back for a second set of revisions.

While preparing your revision, please make sure that you do not use track changes, or insert any comments into the text of the manuscript. You may provide any comments to the editors using the comment link on the manuscript upload screen.

As in the case of your initial submission, you will need to review the converted PDF file and approve the manuscript.

#### Get published

*ECS Transactions* issues for ECS biannual meetings are always published nine days before the first day of the corresponding meeting. You will receive a notification when your paper is accepted, but not when it is published. Please consider following the weekly [ECS eNews](#), or [ECST eTOC alerts](#), to receive updates on new publications.
