

Interface Article Submission Checklist

General

- The manuscript is a single Microsoft Word file.
- Figures and photographs are separate files; they are not only embedded in the manuscript.
- The title is on the first line of the manuscript and is title case.
- The title is 12 or fewer words.
- The names of all authors follow the title.
- Author affiliations are included as department, institution, city, state, country.
- A short abstract (max 150 words) is provided.
- Up to 6 keywords are provided.
- A short biography (max 150 words) of each author is included in the manuscript file.
- A high-resolution (300 dpi minimum) photograph JPG or TIFF file of each author is provided.
- An email address is provided for each author.
- An ORCID iD is provided for those authors who have such.

Text

- The text word count is no more than 3000 excluding references and figure/table captions.
- The text is formatted as Times New Roman font, 12 point type, left-aligned paragraphs, first line indented, 1.5 line spacing with no extra space above or below paragraphs.
- Sections and subsections are NOT numbered.
- There are a maximum of 3 levels of headings in the manuscript.
- The text follows ECS style and the ACS Style Guide.
- Equations are entered as text, created using a math equation editor, or inserted as graphics with the understanding that ECS will re-key all equations from scratch.

Tables

- Tables are constructed with the tables function of Microsoft Word; they are not embedded objects nor do they include embedded objects.
- Each table is referred to by table number in the body of the text.
- Each table has a title placed above and outside the table.
- For any table that is reproduced or adapted from a copyrighted source, permission has been obtained and an appropriate acknowledgment is included if required.

Figures

- The article includes no more than 5 figures.
- Each figure is referred to by figure number in the body of the text.
- Figures are submitted as EPS files or high-resolution (300 dpi minimum) PDF, JPG, or TIFF files at the approximate size (height/width) intended for publication.
- Figures are submitted as individual files; they are not only embedded in the manuscript file.
- Composite figures are submitted in their final, combined form, with all parts labeled appropriately.
- Figure captions are included in the Microsoft Word file; they are not part of the figure file.
- For any figure that is reproduced or adapted from a copyrighted source, permission has been obtained and an appropriate acknowledgment is included if required.

References

- References should be limited to work that is directly correlated to the drafted article
- Number of references should not exceed 50
- Numbered references are cited sequentially throughout text as superscript numbers appearing outside any punctuation if the citation applies to a whole sentence or clause.
- References are listed at the end of the paper in the order they are cited in text.
- References follow ECS journal style.

Keywords: term1, term2, term3, term4, term5, term6

Format text as Times New Roman font, size 12 point, left aligned, first line indented, 1.5 line spacing.

The affiliations will not appear in the print issue; they will only appear in the online version of *Interface*.

The abstract text and the keywords will only appear in the online version of *Interface*.

Begin text here. The article word count should not exceed 3000 words not counting the figure/table captions or the references. Do not include the heading Introduction even if this is the introductory section. Follow the ECS Style Guide for general style.

About the Author(s)

Include a short biography for each author, the author's email, and ORCID iD. Do not embed author photographs in the article file except to show placement only.

Sections and subsections cannot be numbered. Only 3 levels are allowed.

Equations can be entered as regular text or created using the equation editor. Most equations will be re-keyed from scratch.

Create tables in Word and include at the end of the article file. Include figure captions at the end of the article file. Figures can be included in the article file for illustrative purpose only. All graphics (photographs and figures) *must* be submitted as separate files.
